# MINUTES OF THE GENERAL ASSEMBLY OF IGWT

Poznan University of Economics

President Prof. Vogel welcomes all the members present and states the due convening and the quorum (§ 12 of the charter) of the General Assembly.

To commemorate the death of honorary and founding member Otto Gekeler and the death of Prof Anatoliy Miroshnikov, the President of the Ukrainian Association of Commodity Science, a minute's silence is observed.

Prof Vogel gives brief account of the new developments within the association during the past two years.

This data base currently comprises those 120 participants in the IGWT symposium held in Vienna in 1997 that have filled in the corresponding forms.

President Prof Vogel asks to check the entries and to adjust the data if necessary and to send photographs to the Institute of Technology and Commodity Science of the Vienna University of Economics and Business Administration for the attention of Mr Loicht.

Those members that are not yet included in the data base are asked to register at

Once the data base has been adjusted it will not only serve for finding experts within the association but it will also be placed at the disposal of the UNIDO if so requested. In addition each entry can be found world-wide using the search engines.

could be established (please forward information).

➤ IGWT Publication Award

The IGWT Publication Award has been created by the Department of Technology and Commodity Science of the Vienna University of Economics and Business Administration to honour the best authors in the field of commodity science at the event of the IGWT-Symposium in Marburg and in China

The awardee will receive a cash prize of US\$ 1.000 sponsored by this department.

The winners are chosen by a jury which will look for extraordinary scientific achievements by members of national associations.

➤ Advantages of restructuring IGWT membership

Up to now, all members present at the General Assembly had a vote. This constitutes a democratic problem in General Assemblies convened on the occasion of symposia in countries whose national associations have a great number of members. For this reason President Prof Vogel suggests to amend the charter to the effect that only the designated representatives of the national associations shall have the right to vote in the future.

After a debate the motion to regulate the voting rights as shown below is passed by 38 votes to 3.

*„Each national association shall have at least one vote, irrespective of its membership fee.*

*Depending on the number of members of the national association it shall have additional votes:*

<i>1 to 10 members</i>	<i>0 votes (overall 1 vote)</i>
<i>11 to 50 members</i>	<i>1 vote (overall 2 votes)</i>
<i>51 to 100 members</i>	<i>2 votes (overall 3 votes)</i>
<i>more than 100 members</i>	<i>3 votes (overall 4 votes)</i>

*All other full members, honorary members and supporting members only have the right to stand for election and to table motions in the General Assembly.*

- Proposals to amend the charter and to change the German name of the association into Association of Commodity Science. .

The German term „Warenkunde“ denotes a prescientific discipline. Just like the Austrian national association, IGWT should also be renamed. For this reason President Prof Vogel proposes the motion to rename the IGWT in German „Internationale Gesellschaft für Warenwissenschaften und Technologie“. The motion is passed unanimously.

Then President Prof Vogel presents other minor amendments to the charter on the monitor: The establishment of an International Secretariat at the Department of Technology and Commodity Science of the Vienna University of Economics and Business Administration and in the future the President may authorise the Vice-President to represent him, in particular in legal matters concerning the association.

The motions are passed unanimously.

- Proposals to change the method of financing of IGWT

The financial report of the Treasurer shows that the financial position of 1997 could not be maintained due to low revenues and the financial support given to the symposium in Poznan among other things.

President Prof Vogel presents a new method of financing based on the financial resources of the single members which are reflected in the purchasing power parity of each country (based on World Bank data) and the number of members of the national associations.

The idea is that all national associations contribute to the financing, depending on their financial resources.

President Prof Vogel makes the following motion and presents an example for the calculation.

*The financial contributions are determined according to the following valorisation of according to the PPP (Purchasing Power Parity) per capita and the number of members in the national associations. A minimum membership fee may be fixed.*

*PPP per capita in terms of US \$ divided by 1.000 multiplied by the number of national association members divided by 100*

*The calculations will be based on current world bank data*



*By that a minimum budget of IGWT can be financed while the contributions of each single member of the national associations are kept very low.*

*The membership fee for all other full members will stay the same, 10 US\$ per year.*

The motion is passed with 38 votes to 3.

➤ Proposals to reorganise the publication of FORUM WARE

President Prof Vogel reports that the rights to use the title FORUM WARE currently lie with Mr Günther Otto of DGWT.

For the continuation of Forum Ware the rights should be redefined in a new legal contract. The rights could be based at the International IGWT Secretariat at the Department of Technology and Commodity Science of the Vienna University of Economics and Business Administration

He explains his proposal by way of an illustration. A debate on the proposal follows.

The full proposal will have to be negotiated with Mr Otto and DGWT first. In general the association is interested in going on with the publication of a scientifically-oriented periodical with peer review that is recognised by the scientific community. For this reason FORUM WARE requires among other things an additional English title which reflects the subject of the members' activities.

*Renate BUCHMAYR:* Dem Logos zum Trotz – Identitätskonstruktion im Spannungsfeld von Wissenschaft, Mythos und Marketing, Profil Verlag GmbH, München – Wien, 1999.

Dem Logos zum Trotz war es den Wissenschaften der Neuzeit nie völlig gelungen, mythisches Denken und magisches Handeln auszurotten. Dem Logos zum Trotz ist die Differenz zwischen Wissenschaft und pseudowissenschaftlichen Trends momentan oft nur schwer feststellbar. Dem Logos zum Trotz entstehen ständig neue Mythen – genährt von Marketingstrategien, Markenkult und Konsumwunderglauben. Wie also kann es in diesem Machtspiel zwischen Mythos und Logos überhaupt gelingen, Identität zu konstruieren? – Das ist die zentrale Fragestellung dieses Buches.
